# The Assets and Opportunities for Aging in Upper Arlington



August 2021

#### Introduction

The community assessment was conducted through the Upper Arlington Commission on Aging with support from staff and students of Age-Friendly Columbus and Franklin County, the Upper Arlington Commission on Aging Board of Directors and ETC Institute to help define the perceived needs and assets of older adults living within the community of Upper Arlington, Ohio.

The Upper Arlington Commission on Aging (UACOA) is a nonprofit organization whose mission is to "serve as the informed voice empowering, educating and enriching the lives of Upper Arlington residents as we age." Programs provided by the UACOA include educational based outreach, various programs, and connection to community-based services. The UACOA is composed of one part-time executive director, a board of directors, and additional community volunteers. It is important to also note that the UACOA works closely with Upper Arlington city staff, elected officials, and other organizations to provide older adults with valuable information on services available to them and connect them properly to others when needed.


The UA Commission on Aging will utilize the assessment results collected to increase current programming or create new programming to best serve Upper Arlington older adults in alignment with our mission.



## **EMPOWER**

Support residents who want to remain in their homes as they age by providing a variety of choices in programs and services

- Coordinate volunteer support for outdoor home maintenance.
- Coordinate paid support for outdoor home maintenance.
- Coordinate trainings and resources to support drivers such as CarFit events, adaptive devices, car modifications, and Stay Fit to Drive publications.
- Coordinate trainings and resources to support alternative/active transportation and other mobility options such as walking, biking, riding the bus, or scheduling an e-hail.
- Advocate for program, policy or other necessary changes as identified by residents and share opportunities for residents to advocate (ie. Focus groups, surveys by agencies).

# **EMPOWER**

















81.3% of survey respondents indicated it is very important to them that they be able to remain in their current home as they agerent home as they age.

37% of survey respondents indicated they feel very confident that they will be able to get the help needed to live in their current residence; 44% are somewhat confident.

70.0% of survey respondents indicated they have others help them maintain the outside of their house.

10.3% of survey respondents households indicated they are currently a caregiver providing unpaid care for someone else.

39% of survey respondents feel Upper Arlington offers opportunities for older adults to participate in decision making bodies such as committees or councils.

29% of survey respondents feel Upper Arlington offers opportunities to discuss issues that arise as we age. 19% of survey respondents feel Upper Arlington offers transportation to/from places they want to go.

## **EDUCATE**

#### Increase knowledge and connection to information and resources

- Create a new UACOA website to increase accessibility, clarity, and connection to resources and programming.
- Create Upper Arlington Aging Resources information sheet that clarifies the services provided by UACOA, Senior Center, Syntero, and UA CARES and contact information for each. Utilize this information sheet for a "no wrong door" approach to all calls, with each agency agreeing to answer questions and then refer to the most appropriate agency.
- Create and distribute the Resource Guide every two years.
- Create and distribute the Silver Threads newsletter quarterly, through mail, email, social media, and website.
- Coordinate speakers for topics of interest identified by older residents.
- Coordinate walk, park, and business audits to be completed by residents of all ages and abilities to create a list of accessible or age-friendly places.
- Advocate for program, policy or other necessary changes as identified by residents and share opportunities for residents to advocate (ie. Focus groups, surveys by agencies).







# **EDUCATE**





95.6% of survey respondents indicated they have access to the internet.



44.5% of survey respondents can afford the help they need.



43.3% of survey respondents know where to go or whom to call.



37.7% of survey respondents can find someone to answer their question(s).



59% of survey respondents feel Upper Arlington offers easy to find information.

#### **ENRICH**

#### Increase opportunities for purposeful engagement and socialization

- Create on-going meetings and other opportunities for older residents to voice their challenges, ideas for solutions, and interests for programming.
- Create intergenerational programs such as Tech Tuesdays with UA High School students and the Upper Arlington Public Library.
- Coordinate consistent, informal opportunities for peers to meet and connect (Coffee chats, lunch meetings, caregiver meet-ups, movies, etc) that are identified as places of interest by older residents.
- Create and promote a list of accessible places to socialize (based on audits as listed above).

71% of survey respondents feel Upper Arlington offers activities that are accessible.



65% of survey respondents feel Upper Arlington offers activities that both younger and older people can enjoy.



55% of survey respondents feel Upper Arlington offers places to socialize.



Since the COVID-19 outbreak, 64.3% of residents surveyed indicated they feel more socially isolated.
